Dear Secretary,

Licensee requests the Pennsylvania Public Utility Commission ("Commission") withdraw Licensee's natural gas supplier authority granted in Docket A-125050.

Effective December 31st 2015, Licensee changed its name to Constellation Energy Gas Choice, LLC ("CEGC") as part of Licensee's conversion from a corporation to an LLC. Commission Staff advised CEGC to submit a natural gas supplier application. Pursuant to that application, the Commission granted CEGC natural gas supplier authority in Docket A-2016-2542899.

The Commission Staff has recently advised Licensee to submit a request to withdraw its natural gas supplier authority pursuant to Docket A-125050. Licensee requests the Commission to take note of the following:

- In as much as Licensee was converted from a corporation to an LLC, the entity attached to the license granted in Docket A-125050 no longer exists.
- There are no tax issues with the Pennsylvania Department of Revenue as the gross receipts tax is not applicable to natural gas sales.
- There are no open issues regarding contracts or agreements as Licensee's obligations became CEGC's.

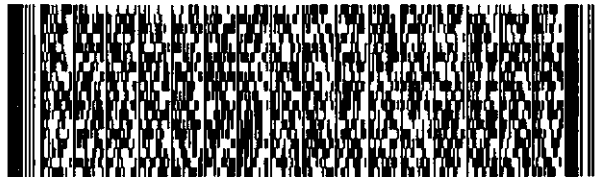

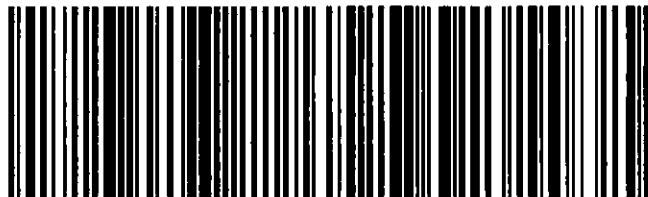
