To Whom It May Concern:

I have contacted my State Farm insurance agent after receiving a letter from PUC requiring me to submit an E-Form, H-form and tariffs to PUC.

An agent, who was in charge of my cargo insurance, completed the H-form in short time and forwarded it to PUC.

When I showed a letter from PUC with requirements to my State Farm agent, who was in charge of my E-form, she said that their insurance company doesn't do E-Forms. This got me by surprise because prior to that they took a copy of PUC's E-Form requirements and said they would prepare it, but it would take some time.

I have demanded a certificate of insurance from them, where all my trucks were listed, and I have sent it to you.

When I received a letter of rejection from you, I was very upset and remanded from my insurance company an explanation why the preparation of my E-Form was so delayed.

After that they told me that I would have to pay them \$220.59 for the E-Form for 6 months. After 5-6 days, the agent contacted me by phone and told me that the E-Form was filed, and everything was in order. It was on 06/13/2017.

The tariff has been submitted through TriState Tariff broker and should have been already received.

I would like to ask you to kindly reconsider your decision of rejection, and give me a little more time or another chance to submit all the required documents and forms. I would greatly appreciate your understanding!


