
1. On April 4, 2017, the Commission served the Respondent with the Complaint filed in the above captioned matter, which is a theft bill dispute.
2. On April 24, 2017, PGW filed an Answer to the Complaint in the above captioned matter.
3. By Notice dated May 22, 2017, the Commission scheduled an In-Person Hearing in this matter for Friday, July 7, 2017 at 10:00 a.m., before Administrative Law Judge Eranda Vero.
4. The assigned Customer Review Unit Officer, Jessica Glace, has been out of the office since June 27, 2017 due to a death in the family. Ms. Glace is not expected back at the office until July 3, 2017. Because she is on leave, Ms. Glace has been unable to compile the information necessary to generate exhibits for this case.
5. July 4, 2017 is a federal holiday.
6. On Friday, July 7, 2017, a necessary PGW witness, John Bucher, will be unavailable to testify due to a previously scheduled vacation from July 3, 2017 through July 10, 2017. Mr. Bucher will be back at the office as of July 11, 2017.

this matter. Mr. Reddick objects.

WHEREFORE, Complainant requests that the hearing scheduled for Friday, July 7, 2017, in the above captioned matter be continued and rescheduled so that PGW may have all of its witnesses available.
