Because ITC’s financial statements are already on file at the Commission under seal (i.e. not open to public review), there is no need to separately request confidential treatment of those materials – it is simply requested that the existing confidential treatment of those materials be maintained for purposes of their consideration in support of this Application.

Finally, we have included an additional copy of the Application and attachments and ask that you please stamp it as received and return it in the postage pre-paid envelope provided.




