
On May 19, 2017 we submitted on behalf of Stream Energy Pennsylvania, LLC ("Stream Energy") a Letter Petition to renew its bond at the reduced level of 5%. On June 5, 2017, Staff issued data requests to Stream Energy requesting: (1) evidence of prepaid gross receipt taxes; and (2) AEPS compliance data. Enclosed please find the following documentation in support of Stream Energy's Letter Petition:

- 1) Stream Energy has prepaid its gross receipt taxes to the Pennsylvania Department of Revenue for its estimated gross revenues for the current year. Proof of the prepaid gross receipt taxes is provided in Attachment A (**CONFIDENTIAL**).
- 2) Stream Energy was compliant with AEPS requirements in 2016, as evidenced by the letter provided by the Pennsylvania AEPS Administration Team in Attachment B (**CONFIDENTIAL**).
- 3) A verification attesting to the truthfulness of facts set forth in this letter.

Stream Energy requests confidential treatment of the enclosed attachments marked as Confidential as Stream Energy is a privately held company and is not subject to public reporting requirements with respect to the information, and Stream Energy does not publish or otherwise make available for use by the general public or its competitors its financial, business operation or tax information.
