On May 24, 2017, the Commission issued ALJ Heep's Initial Decision in this matter.

On June 7, 2017, Complainant Catherine Frompovich filed her Exceptions to the Initial Decision.

On June 23, 2017, PECO filed its Reply Exceptions.

On July 6, 2017, PECO received a document, dated July 3 and entitled "Catherine J. Frompovich Reply to PECO Energy Company Exceptions."

On July 10, 2017, PECO received a letter, dated July 3, from Thomas A. McCarey,<sup>1</sup> which also nominally responds to PECO's Reply Exceptions.

The Commission's regulations do not provide an opportunity for replies to Reply Exceptions. *See generally*, 52 Pa. Code §§ 5.533 and 5.535. The Commission typically does not consider such filings in reaching its final determinations. PECO therefore will not file a substantive response to the Frompovich or McCarey documents referred to above, absent further instructions from the Commission to do so.
