Dear Ms. Chiavetta,

1. I am in receipt of Attorney Larry R. Crayne's letter dated 13 June 21-2017 that enclosed an electronically filed copy of UGI Utilities, Inc.'s Answer to Formal Complaint. I found several discrepancies in their answers that I wish to address at a **"PHYSICAL"** hearing before the PUC Administrative Law Judge. Most notably, that I made several requests to several UGI departments to gain a comprehensive history of all service calls and delinquencies at the subject property of 429 Crescent St. but nothing was forthcoming. I was repeatedly told by UGI officials that the only service call on record was the one Akeem Simmons and I made on 7 February 2017 that we know, even by their accounts, was a false statement.
2. UGI's failure to acknowledge and accept that there were previous tenants, Tracie Sullivan and Jasmine Benner by lease dated 12 July 2016 (lease UGI had in their possession) and that there were/is sufficient evidence that vagrants/squatters were in said property and that I filed several complaints with the Harrisburg Police Department to investigate the matter and the possibility of criminal activity is negligence on the part of UGI.
3. Attorney Crayne, in item 8 of his letter, states that I do not have the capacity to represent the Complainant. I argue that this is not his decision to make but should be the decision of the PUC. I alone have valid information and documentation about this property and this matter; in addition to valid information and documentation concerning other parties who have valid information and documentation and am the best person to present a chronology of facts.
4. I strongly dispute Attorney Crayne's request for Telephonic Hearing. Due to the severity and complexity of these matters, I strongly request a **"PHYSICAL"** hearing be schedule before the PUC Administrative Law Judge. Since I teach aquatics in the summers from 11am to 6pm, and so as to not disrupt my students, I


