REF: C-20172606955 Intent to Suspend/Revoke Authority

I have received your correspondence in regard to the intention to suspend/revoke our authority due to a violation to maintain insurance.

The reason we currently have no insurance, is that our carrier abruptly stopped servicing the limousine industry and only gave us 2 week notice to obtain a new policy.

I also want to state that none of our vehicles has been driven or operated during the time our insurance was not active. Our vehicles are parked inside our garage and have never been operated.

However we are currently still searching for a new policy (see attached correspondence) with an agent who is trying to obtain a new policy for us.

I have also attached correspondence from our agent showing that the policy was cancelled not because of our fault but because the carrier stopped offering our type of insurance.

We are kindly requesting an extension of 4 weeks to obtain a new policy.
