

## A. EXPERIENCE, PLAN, STRUCTURE

# 1. Experience

Spring Energy RRH, LLC's officers and management came to the Company with years of experience managing the kinds of business, technical and customer service issues that commonly arise during the operation of a retail natural gas and electric supply company.

#### a. Owners

Donald Cheesman and Stephen Eskrigge have a strong record of establishing and managing successful energy companies in deregulated markets. They have been major shareholders and the key managers of six successful energy companies in the deregulated energy markets in the United States, Australia and New Zealand: Kiwi Energy NY LLC, Frontier Utilities Inc., Energy Online, Victoria Electricity, Queensland Electricity, Direct Connect Australia Pty Ltd. The New Zealand market has been fully deregulated since 1998 while the Victorian market in Australia deregulated in 2003. In the past few years, Victoria has been one of the most competitive energy markets in the world. The Queensland market in Australia opened to competition in 2007 and now rivals Victoria for competitiveness.

Richard Booth brings 10 years of experience in overseeing operations and acquiring customers in the competitive energy markets in the United States, New Zealand and Australia. Richard is currently the President of Retail Operations at Kiwi Energy NY LLC. Richard oversees the operations at Kiwi Energy NY LLC, an energy supplier in New York, and Spring Power & Gas, an energy supplier in New Jersey and Maryland. The Companies currently have a combined customer base of more than 85,000. Previously, Richard was in a similar role at Frontier Utilities based in Texas. Prior to his role at Frontier Utilities, Richard was the General Manager of Sales and Marketing at Victoria Electricity. Richard was responsible for a team of 200 employees which consisted of 12 supply partners and 150 staff members. This team covered customer acquisition and retention, and marketing and electricity, gas and telecommunications markets in Victoria, New South Wales, Queensland and South Australia. Richard's team was also responsible for Ecogold, a loyalty program which included an environmental fund with ongoing communication of special offers to customers from various business partners. When Richard left Victoria Electricity to set up Frontier Utilities in Texas, the Company had more than 400,000 customers. Prior to joining Victoria Electricity, Richard managed the commercial sales team at Energy Online.

Lisa Hawkins joined Kiwi Energy as the Chief Financial Officer in April 2012. Lisa is responsible for managing the financial and economic risks of the Company. She manages the financial planning, record keeping, and reporting for Kiwi Energy. Prior to joining Kiwi, Lisa was a Manager within the Assurance Practice at PricewaterhouseCoopers, LLP ("PwC"). There, she gained significant experience in public and private client audits within a range of industries including mortgage banking, oil & gas, manufacturing, and other financial services. She assisted her clients with SEC filings, including Form 10-K and 10-Q filings, governmental compliance requirements and public and private debt/equity offering transactions. She has served multinational corporations as well as venture capital funds. She earned a Bachelor's

degree in Business Administration and Master in Professional Accounting from The University of Texas and is a licensed Certified Public Accountant in both the states of Texas and New York.

Michael Lordi has been the VP of Supply for Kiwi Energy since July 2014. He has over 25 years of experience in the energy industry. After receiving a degree in electrical engineering, Michael joined the transmission planning department at Consolidated Edison Company in New York. He continued power system planning and operations at the Northeast Power Coordinating Council (NPCC). At NPCC, Michael performed studies that determine power transfer capabilities in the Northeast and Mid-Atlantic regions. Michael moved to trading electricity and natural gas when he joined Enron Power Marketing. Michael next held senior trading position at Duke/Louis Dreyfus and CNG Energy Services. At CNG, Michael was responsible all wholesale and retail electricity activities. Following CNG, Michael joined Électricité de France (EDFT) in London. At EDFT, he was head of all electricity trading and asset optimization in Europe. Before joining Kiwi Energy, Michael was the Executive Director of Retail Energy Business Development at Gulf Oil. At Gulf Oil, Michael was responsible for the retail electric business unit including supply desk activities.

# b. Previous Experience in the Industry

Spring Energy RRH, LLC

Pure Energy USA LLC was originally formed on November 14, 2013 as a Delaware Limited Liability Company. A Certificate of Amendment was filed and Pure Energy USA LLC changed its name to Spring Energy RRH, LLC on February 3, 2015.

On July 22, 2015, the Maryland Public Service Commission granted Spring Energy RRH, LLC d/b/a Spring Power & Gas ("Spring Power & Gas") a license to supply electricity (License Reference No. IR-3537) and a license to supply natural gas (License Reference No. IR-3550) (See Exhibits 11 and 12). It is currently active in the Baltimore Gas & Electric service territory and is planning on expanding into Washington Gas and Pepco. Spring Power & Gas markets to residential customers.

On July 22, 2015, the New Jersey Board of Public Utilities granted Spring Energy RRH, LLC d/b/a Spring Power & Gas ("Spring Power & Gas") a license to conduct business as an electric power supplier (License No. ESL-0176) and as a gas supplier (License No. GSL-0153) (See Exhibits 13 and 14). The current utility service areas are: Public Service Enterprise Group (PSEG), Jersey Central Power & Light (JCP&L), and New Jersey Natural Gas (NJNG). Spring Power & Gas markets to residential customers.

Spring Power & Gas has contracted with approximately 6,820 electric customers and approximately 6,310 natural gas customers in the New Jersey and Maryland markets.

**Affiliates** 

Spring Energy RRH, LLC has several affiliates. One affiliate is Kiwi Energy NY LLC d/b/a Kiwi Energy, Kiwi Energy NY LLC was formed in December 2008, (originally incorporated as Frontier Utilities Inc. (NY)) with Donald Cheesman and Stephen Eskrigge as shareholders. In 2012, with the sale of their Texas based company Frontier Utilities Inc., the shareholders rebranded Frontier Utilities Inc. (NY) as Kiwi Energy and the operations were moved from Texas to New York. Kiwi Energy markets predominantly to New York residential with some small commercial customers and has contracted with more than 85,000 customers in New York. The current utility service areas include the following:

National Grid, ConEd, New York State Electric & Gas, Rochester Gas & Electric, and Central Hudson. Kiwi Energy recently applied for a license to be an electric and natural gas supplier in Ohio.

Another affiliate is Arrow Energy RRH, LLC d/b/a Arrow Energy. Arrow Energy RRH, LLC is Delaware Limited Liability Company, formed on February 12, 2015. On January 20, 2016, the Public Utilities Commission of Ohio certified Arrow Energy RRH, LLC to be a retail natural gas marketer (Certificate No. 16-494G(1)) (See Exhibit 15) On January 28, 2016, the Public Utilities Commission of Ohio certified Arrow Energy to be a retail electric service supplier (Certificate No. 16-1041E(1)) (See Exhibit 16). Arrow Energy has not yet commenced business in Ohio.

# c. Previous Experience in the Industry: Continued

# Frontier Utilities Inc.

Frontier Utilities Inc. was formed in August 2008 with Donald Cheesman and Steve Eskrigge as shareholders. Frontier Utilities commenced trading in 2009. Frontier Utilities Inc. grew to more than 10,000 customers where is was acquired by the Quintana Group in 2011 which allowed the principles to concentrate on their Northeast energy business.

## Victoria Electricity

Victoria Electricity was formed in 2002 with Donald Cheesman, Steve Cheesman and listed investment company Infratil (see www.infratil.com) as shareholders. Victoria Electricity commenced trading in 2004 and currently supplies in excess of 300,000 customers. In 2007, Infratil purchased Cheesman and Eskrigge's shares and now holds 100 percent of the company. Victoria Electricity has been responsible for approximately 30% of market churn in Victoria. Queensland Electricity Pty Ltd, NSW Electricity Pty Ltd, South Australia Electricity Pty Ltd, run a similar model to Victoria Electricity and were also purchased by Infratil in 2007. In 2010, they were consolidated into one company called Lumo Energy (see www.kumoenergy.com.au).

# Direct Connect Australia Pty Ltd

Direct Connect was founded by Donald Cheesman and Steve Eskrigge in 2004 and is the dominant utility connection company in Australia providing energy, telecommunications, insurance and other products to individuals and customers who are moving locations. This company provides energy retailers with direct access to the large moving market and assists more than 300 people per day to move premises (see www.directconnect.com.au).

# Energy Online Ltd

Energy Online (EOL) was established by Donald Cheesman and Steve Eskrigge in 1998 to seize the opportunity provided by the deregulating New Zealand energy market. After an initial growth period, Cheesman and Eskrigge sold their shares to a telecommunications company, Newcall Communications, but remained on the Board and operationally responsible for the company. In 2002, Energy Online was sold to Genesis Power, the largest integrated generator retailer in New Zealand. Genesis continues to operate Energy Online independently as a growth brand. EOL currently supplies more than 60,000 customers (refer to www.energyonline.co.nz)

# Agility CIS Ltd

Agility CIS Ltd. (Agility) is a New Zealand-based company, providing billing and customer-management solutions to Australasia's retail energy companies. Since 1998 Agility has been developing, integrating and supporting its flagship product, Orion, a comprehensive system for customer management and utility service billing. Orion is designed and developed to facilitate flexibility and ease of use in a competitive, service-focused market. Orion can be tailored for any specific requirement, and fully supports electricity, gas, internet/data and water products. Agility is the dominant system supplier to second tier retailers in Australasia and supports a number of energy retail operations in the U.S. including Frontier Utilities and Kiwi Energy (refer to www.agilitycis.co.nz).

# 2. Business Plan for Pennsylvania, Staffing Structure and Employee Training Commitments

Spring Power & Gas plans to market and contract with residential customers. This will likely be done through a variety of marketing and sales channels, such as door-to-door, telemarketing and online enrollment. We will offer variable and fixed price products. Spring Power & Gas will use utility consolidated billing to provide bills to customers and will post rates to the Pennsylvania Power to Switch as required.

Spring Power & Gas has a Regulatory and New Markets Manager (also a licensed attorney) that reviews and approves marketing materials and ensures compliance with the applicable Commission regulations. In addition, Spring Power & Gas has obtained outside legal counsel to further ensure compliance. The Regulatory and New Markets Manager works closely with the Operations Manager and the President of Retail Operations to oversee training and to investigate and respond to customer complaints. Spring Power & Gas will maintain a customer service hotline for customers in Pennsylvania, in addition to an e-mail address in order to respond to customer inquiries and complaints. Spring Power & Gas has a customer service team of approximately four agents. These agents are available during normal business hours to respond to customer inquiries and concerns. They are overseen by our Customer Service Supervisor.

For information on our quality assurance process and training, please see section D below relating to the oversight of marketing.

### **B. PROPOSED MARKETING METHOD**

Spring Power & Gas will use its own internal resources/employees for marketing. Additionally, Spring Power & Gas will likely contract with an external third-party (a Non-NGS). For more information on how Spring Power & Gas will monitor an external third-party marketer, please see section D of this exhibit relating to our quality assurance process.

# C. DOOR TO DOOR SALES

Spring Power & Gas will likely be implementing door-to-door activities. We will use an independent third-party verification. In order for Spring Power & Gas to accept enrollment, a customer must verbally confirm their authorization to switch supply service. During the verification, the customer

must acknowledge key points of service. If any portion of the third-party verification is incomplete, then Spring Power & Gas will not process the enrollment.

#### D. OVERSIGHT OF MARKETING

Spring Power & Gas plans to contract with customers directly through traditional marketing and sales methods, including but not limited to, door-to-door, telemarketing and online enrollment. In all marketing and sales operations, Spring Power & Gas will adhere to all Pennsylvania consumer protection laws, PUC regulations and standards, and utility market rules and procedures. Spring Power & Gas will use third party verification when required in its sales and marketing activity and will enroll customers consistent with the procedures outlined in the Pennsylvania Code.

Spring Power & Gas has a Regulatory and New Markets Manager (also a licensed attorney) that reviews and approves marketing materials and ensures compliance with the applicable Commission regulations. In addition, Spring Power & Gas has obtained outside legal counsel to further ensure compliance.

In Maryland and New Jersey, Spring Power & Gas developed a comprehensive quality assurance program. Spring Power & Gas intends to implement the same program in Pennsylvania. Spring Power & Gas will train all agents through its internal and external sales onboarding process and will regularly investigate the activities of its sales agents. If a complaint arises with a particular sales agent, we will audit that agent's activities in accordance with the quality assurance process. Spring Power & Gas will provide training alerts on at least a weekly basis to its sales channel regarding important training topics or specific issues. The trainings will be signed by the trainees. The quality assurance results will be reviewed weekly with the Spring Power & Gas Quality Assurance Specialist, the Operations Manager and the President of Retail Operations.

**Background** 

Spring Energy RRH, LLC ("Spring Power & Gas" or "Spring") is licensed by the Pennsylvania Public Utility Commission ("PUC") to offer natural gas supply and electric generation supply services in Pennsylvania. Our PUC license numbers are \_\_\_\_\_\_ (Electric License) and \_\_\_\_\_\_ (Gas License). We set the generation prices and charges that you pay. The PUC regulates distribution prices and services. Your electricity generation prices and charges will be set by Spring. The Federal Energy Regulatory Commission regulates electricity transmission prices and services. Natural gas commodity prices and charges are set by Spring The Public Utility Commission regulates electricity and natural gas distribution prices and services. You will continue to receive your bill from your Electric Distribution Company (NGDC) for all natural gas supply and delivery charges. Your EDC and NGDC will continue to provide all emergency repairs and services. Spring is not affiliated with and does not represent your EDC or NGDC.

#### **Definitions**

<u>Generation Charge</u> - Charge for production of electricity. <u>Transmission Charge</u> - Charge for moving high voltage electricity from a generation facility to the distribution lines of an electric distribution company. <u>Interstate Pipeline Charges</u>- Charges for moving natural gas to the distribution lines of a distribution company. <u>Commodity Charges</u>- The charges for the natural gas product which is sold either in cubic feet or dekatherms. <u>Distribution Charges</u>- The charge for the delivery of natural gas from the city gate to the consumer.

- 1. Authorization to Switch and Agreement to Sell and Purchase Natural Gas and/or Electricity. This is an agreement between Spring Energy RRH, LLC d/b/a Spring Power & Gas ("Spring") and the undersigned customer ("Customer") under which Customer agrees to obtain electric generation and/or natural gas supply service from Spring (the "Agreement"). Subject to the terms and conditions of this Agreement, including the attached Contract Summary, Spring agrees to sell and deliver, and Customer agrees to purchase and accept, the quantity of electricity and/or natural gas, as estimated by Spring, necessary to meet Customer's requirements based upon consumption data obtained by Spring or the delivery schedule of the NGDC and/or EDC. The amount of electricity and/or natural gas delivered under this Agreement is subject to change based upon data reflecting Customer's consumption obtained by Spring.
- 2. Contract Length. This Agreement will begin on the date set by your NGDC and/or EDC and will continue on a month-to-month basis until cancelled by either the Customer or Spring. Either party may cancel or terminate this Agreement by providing 30 days' advance written notice of termination to the other party.

- 3. Right of Rescission. You may cancel this Agreement at any time before midnight of the third business day after receiving this disclosure statement. You can contact us by phone or in writing to cancel this agreement.
- 4. Pricing, Billing, and Termination. Through our Spring Green program, your electric consumption is matched with our Green-e Energy certified Wind RECs (Renewable Energy Certificates) (see Section 6). The price for Spring Green includes electricity and our Wind REC product. The price of electricity and our Wind REC product is variable. Your rate for electricity will be a variable price per kilowatt hour. Your initial rate for the first billing cycle is set forth in your Contract Summary. Unless otherwise agreed to in writing, the price for all electricity sold under this Agreement shall be a variable price per kWh which shall reflect the wholesale cost of electricity obtained from the PJM Interconnection (including capacity, energy balancing, settlement, ancillaries), related transmission and distribution charges and other market-related factors, RECs, and Spring's costs, expenses and margins. This price includes transmission charges and estimated total state taxes (including Gross Receipts Tax), but excludes sales tax. There is no limit on the amount that your price can decrease or increase from month to month. Your Spring electricity price may be higher or lower than the EDC's price in any particular month, and there is no maximum price. Spring does not guarantee any savings.

For natural gas, under Spring's Zero Gas program, your natural gas consumption is matched with carbon offsets (see Section 7). The cost of natural gas and the carbon offsets is variable. Your rate for gas will be a variable price per therm. Your initial rate for the first billing cycle is set forth in your Contract Summary. Unless otherwise agreed to in writing, the price for all natural gas sold under this Agreement shall be a variable price per therm which shall reflect the wholesale cost of natural gas obtained from the NYMEX exchange (including commodity, capacity, storage and balancing), carbon offsets, if applicable, transportation to the Delivery Point, and other market-related factors, and Spring's costs, expenses and margins. There is no limit on the amount that your price can decrease or increase from month to month. Your Spring natural gas price may be higher or lower than the EDC's price in any particular month, and there is no maximum price. Spring does not guarantee any savings.

Customers can call Spring at 1.888.710.4782 or visit our website at <u>www.springpowerandgas.us</u> for current variable pricing and the previous 24 months' average billed historical prices (or as many months of data as is available to date, up to 24 months). *Please note that historical prices are not indicative of present or future pricing.* 

You agree and understand that there are no limits on how much your price for natural gas and electricity can fluctuate from month to month. You will not be notified of price changes until your new price appears on your bill. Spring does not offer budget billing for your natural gas and/or electricity supply service charges. Customer will receive a single bill from the EDC which will includes both the EDC's distribution charges and Spring's charges for electricity supply. Your EDC maintains the right to terminate service for any unpaid utility or supplier charges, pursuant to the regulations of the Pennsylvania Public Utility Commission. Customer will receive a single bill from the NGDC which will includes both the NGDC's distribution charges and Spring's charges for natural gas supply. Your NGDC maintains the right to terminate service for any unpaid utility or supplier charges, pursuant to the regulations of the Pennsylvania Public Utility Commission. A \$30 fee will be charged for all returned payments.

If there is a material adverse change in the business or financial condition of Customer (as determined by Spring at its discretion), or if the NGDC or EDC is or becomes unable or unwilling to invoice Customer directly for the electricity and/or natural gas delivered under this Agreement, or if the Customer's usage of electricity or natural gas materially decreases by more than 25% as measured against the same month in the previous year, or if the Customer fails to disclose to Spring any material change affecting or expected to affect the Customer's usage of electricity or natural gas (including, but not limited to the installation of onsite generation), or if Customer fails to meet its obligations under this Agreement or pay or post any required security deposit, then, in addition to any other remedies that it may have, Spring may terminate this Agreement in accordance with the provisions of Section 9 of this Agreement.

**5. Supply Rewards.** Spring will provide to Customer EITHER a "5% Ecogold Rewards OR a "3% Cash Back" on the electricity and/or natural gas commodity supply charges for active accounts as chosen by the customer following the commencement of electricity and/or natural gas commodity service under this Agreement. Active accounts are defined as those (i) that are billing more than \$0 and (ii) for which Spring has not received a request on behalf of the customer to discontinue service.

The 5% Ecogold Rewards will be equal to 5% of the natural gas and/or electricity commodity supply charges billed by the NGDC and/or EDC on behalf of Spring under the consolidated bill, exclusive of sales taxes and delivery, transportation, and transmission charges. The Ecogold Rewards will initially be awarded once the reward is equal to \$25. All subsequent rewards will be awarded once the reward is equal to \$50.

The Cash Back will be 3% of the 12 month consecutive natural gas and/or electricity commodity supply charges billed by the NGDC and/or EDC on behalf of Spring under the consolidated bill, exclusive of sales taxes and delivery, transportation, and transmission charges. Customer must remain with Spring for 12 consecutive billing cycles to receive any Cash Back. The Cash Back will be mailed to the customer within approximately 60 days following each 12th monthly billing cycle that Customer takes service from Spring.

Checks that remain uncashed after one year will incur an administrative fee of \$2.00 per month, allowing us to continue to make the check negotiable and funds available. This fee is non-recoverable and non-refundable.

- 6. Renewable Energy Certificates (REC). The Spring Green program, which qualifies for Ecogold benefits, ensures that the customer's electricity usage is matched 100% with Renewable Energy Certificates ("RECs") sourced from national renewable wind resources. Our Wind REC product is a Renewable Energy Certificate (REC) product and does not contain electricity. The price you are charged for electricity supply includes the cost of RECs from Spring Power & Gas in addition to electricity. A REC represents the environmental benefits of 1 megawatt (MWh) of renewable energy that can be paired with electricity. For more information, see www.green-e.org/rec. The cost for Spring to purchase the RECs is included in your price. Spring may take up to 12 months after the end of each calendar year under which this agreement is in effect to address any deficiency that may arise in the renewable content of electricity sold under this agreement in the previous calendar year. Spring does not guarantee that this product will be offered in the future or on a continuing basis and will notify customer 3 months in advance via the Spring website if Spring is no longer able to purchase RECs.
- 7. Carbon Offset Natural Gas. Spring's Zero Gas program, which qualifies for Ecogold benefits, is a carbon offset natural gas program that ensures that Spring offsets 100% of the carbon dioxide emissions

from the customer's natural gas use by purchasing carbon offsets. The carbon offsets come from forestry projects. The greenhouse gas emissions being offset with Zero Gas are those associated with the combustion of natural gas at the point of consumption only, and do not include lifecycle emissions that occur during extraction, production, or delivery. Spring calculates the appropriate amount of carbon offsets to purchase based on figures provided by the United States Environmental Protection Agency. Spring may take up to 12 months after the end of each calendar year under which this agreement is in effect to address any deficiency that may arise in the carbon offset content of gas sold under this agreement in the previous calendar year. Spring does not guarantee that this product will be offered in the future or on a continuing basis and will notify customer 3 months in advance via the Spring website if Spring is no longer able to purchase carbon credits. For information on how to calculate the quantity of carbon offsets, the Customer should refer to the Carbon Offset Content Label.

- **8.** Assignment. Customer may not assign its interests in and delegate its obligations under this Agreement without the express written consent of Spring. Spring may sell, transfer, pledge, or assign the accounts, revenues, or proceeds hereof, in connection with any financing agreement and may assign this Agreement to another entity.
- 9. Information Release Authorization. Customer authorizes Spring to obtain and review Customer Information which includes, but is not limited to, customer name, address, telephone number, usage habits or history, peak demand and payment history, and information regarding Customer's credit history from credit reporting agencies. This information may be used by Spring to determine whether it will commence and/or continue to provide energy supply service to Customer and will not be disclosed to a third party unless required by law. Customer's execution of this Agreement shall constitute authorization for the release of this information to Spring. This authorization will remain in effect during the Initial Term and any Renewal Term. Customer may rescind this authorization at any time by providing written notice thereof to Spring or by calling Spring at 1.888.710.4782. Spring reserves the right to terminate this Agreement pursuant to the provisions of Section 9 of this Agreement in the event Customer rescinds the authorization.
- 10. Termination Rights. The services provided by Spring to Customer are governed by the terms and conditions of this Agreement. As set forth in Section 10 of this Agreement, the Customer has 3 business days to rescind the Agreement until it becomes binding (the "Rescission Period"). During this period, Spring may elect to not enroll a Customer pursuant to Section 8 of this Agreement. Spring shall have the right to terminate this Agreement in the event of a breach of the term(s) of the Agreement by Customer, including, but not limited to, failure to remit payment as required under this Agreement. Spring will provide at least 30 days' written notice prior to the termination of service and provide Customer with the opportunity to remedy the termination condition.

- 11. Residential Customer Rights. Customer will receive a confirmation notice of its choice from their EDC and/or NGDC, and Customer will have 3 calendar days from the date of such confirmation notice to contact the LDC and rescind its selection. This Agreement shall not be effective upon the residential Customer until the 3—day rescission period has expired, and neither the Customer nor Spring has directly or indirectly, rescinded the selection or terminated enrollment. There is no charge for the residential Customer for starting or stopping electric or gas supply service if done within the terms of this Agreement. Switching to a competitive supplier such as Spring is not mandatory and Customer has the option of remaining with the NGDC for natural gas supply and the EDC for electricity supply.
- 12. Agency-Electric. Customer hereby designates Spring as agent to; (a) arrange and administer contracts and service agreements between Customer and Spring and those entities including PJM engaged in the generation, transmission and delivery of Customer electricity; and (b) nominate and schedule with the appropriate entities including the EDC for the delivery of electricity to the Customer's end-use premises. Spring as agent for the Customer will schedule the delivery of adequate supplies of electricity that meet the Customer's requirements as established by the EDC and in response to information provided by the EDC. The Delivery Points for the electricity will be a point at the PJM Spring load bus. These services are provided on an arm's length basis and market-based compensation is included in the price noted above.

Agency-Gas. Customer hereby designates Spring as agent to; (a) arrange and administer contracts and service agreements between Customer and Spring and between the interstate pipeline transporters of Customer natural gas supplies; (b) nominate and schedule with the interstate pipeline the transportation of Customer's natural gas supplies to the Delivery Points, and with the NGDC for the transportation of the Customer's natural gas supplies from the Delivery Points to the Customer's enduse premises; and (c) aggregate Customer's natural gas supplies with such supplies of other customers served by Spring to maintain qualification for NGDC transportation service and resolve imbalances that may arise during the term of this Agreement. Spring as agent for the Customer will schedule the delivery of adequate supplies of natural gas that meet the Customer's requirements as established by the NGDC and in response to information provided by the NGDC. The Delivery Points for the natural gas transported by interstate pipelines will be the city gate stations of the NGDC. Spring agrees to arrange for the transportation of the natural gas supplied under this Agreement from the Delivery Points to the Customer's end-use premises. These services are provided on an arm's length basis and market-based compensation is included in the price noted above.

- 13. Title. Customer and Spring agree that title to, control of, and risk of loss to the electricity and/or natural gas supplied by Spring under this Agreement will transfer from Spring to Customer at the Delivery Point(s). Spring will indemnify and hold harmless Customer from all taxes, royalties, fees or other charges incurred before title passes with respect to the electricity and/or natural gas provided hereunder.
- 14. Warranty. This Agreement, including any enrollment form and applicable attachments, as written makes up the entire Agreement between Customer and Spring. Spring makes no representations or warranties other than those expressly set forth in this Agreement, and Spring expressly disclaims all other warranties, express or implied, including merchantability and fitness for a particular use.
- 15. Force Majeure. Spring will make commercially reasonable efforts to provide electricity and/or natural gas hereunder but Spring does not guarantee a continuous supply of electricity and/or natural gas to Customer. Certain causes and events out of the control of Spring ("Force Majeure Events") may

result in interruptions in service. Spring will not be liable for any such interruptions caused by a Force Majeure Event, and Spring is not and shall not be liable for damages caused by Force Majeure Events. Force Majeure Events shall include acts of God, fire, flood, storm, terrorism, war, civil disturbance, acts of any governmental authority, accidents, strikes, labor disputes or problems, required maintenance work, inability to access the local distribution utility system, non-performance by the EDC or NGDC (including, but not limited to, a facility outage on its gas distribution lines), changes in laws, rules, or regulations of any governmental authority or any other cause beyond Spring's control.

16. Liability. The remedy in any claim or suit by Customer against Spring will be solely limited to direct actual damages (which will not exceed the amount of Customer's single largest monthly invoice amount in the immediately preceding 12 months). In no event will either Spring or Customer be liable for consequential, incidental, indirect, special or punitive damages. These limitations apply without regard to the cause of any liability or damages. There are no third-party beneficiaries to this Agreement.


