I am writing you in regard to Docket No. C-2017-2613125, a complaint which is filed against me, Joe David Sergent, II, T/A Digger Dave Premier Property Services.

I contest the complaint against me based on the following information:

- 1) I closed my hauling business and my DOT authority on 4/3/17.
- 2) As part of the process of cancelling my DOT authority, I contacted the DOT Safety Inspector and PUC Enforcement Supervisor, Mr. Brian Mehus, of the Western Regional Office in Pittsburgh. Please see attachment A.
- 3) Mr. Brian Mehus confirmed that my DOT authority had been closed and sent me a copy of the form to cancel my PUC authority as well. He stated in his message that I should return the PUC form to his office and it would be taken care of. Please see copy of the form, attachment B, which I mailed back on 4/7/17, to the address per his direction.
- 4) I did not cancel my insurance until 5/5/17 after mailing the completed PUC form to Mr. Mehus on 4/7/17, even though I no longer held DOT authority and no longer was in the hauling business. I purposely did not drop my insurance coverage until Mr. Mehus and the PUC had more than ample time to receive the form in the mail and cancel my PUC authority. Please see attachment C – insurance policy cancellation notice.

I very much appreciate your consideration and assistance with a reasonable conclusion to this matter.
