Dear Secretary Chiavetta:

Verde Energy USA, Inc. ("Verde") submits this letter as notice to the Pennsylvania Public Utility Commission ("Commission") that Verde was acquired by CenStar Energy Corporation ("CenStar") that is wholly-owned by Spark Holdco, LLC with ultimate ownership residing in Spark Energy, Inc. ("Spark") effective July 1, 2017. Under the transaction Verde is wholly owned by CenStar. CenStar is wholly owned by Spark Holdco, LLC. Spark has 39.47% Managing Membership Interest in Spark HoldCo, LLC. This notice is provided in accordance with 52 PA. Code §54.34, to notify you of a change in organizational structure in the entity licensed under Docket No. A-2012-2151038 on March 25, 2010.

Pursuant to the transaction, neither Verde, CenStar, nor Spark intend to make any changes in Verde's services or customer population for the foreseeable future, other than changes made in the ordinary course of business. Verde will continue to be operated consistent with past practice for at least 18 months following July 1, 2017. The transaction will be a non-event for customers: Verde will not be changing rates as a result of the transaction, existing management will continue to operate Verde, the Verde name will continue – this is not an assignment or sale of Verde's customer contracts – and the current customer experience with Verde will remain the same. While the current officers of Verde have resigned their offices, they will continue to serve actively as part of Verde's management team, which team will now also include personnel from CenStar and Spark who are experienced in operating retail electricity suppliers in many states, including in Pennsylvania. Accordingly, Verde's management team will continue to have the requisite technical, managerial and financial capabilities to operate an electric supplier company.

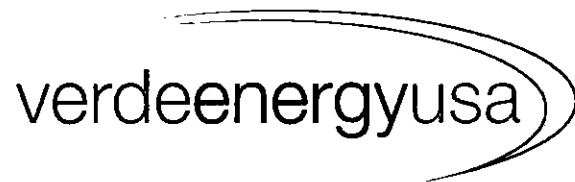
