



If Duquesne Light's Preliminary Objections have been or are to be denied, Duquesne Light respectfully requests that the hearing in this matter be continued for 30 to 60 days so that Duquesne Light can file an Answer and New Matter to the Formal Complaint and to allow Complainant sufficient time to file a Reply to Duquesne Light's New Matter, if necessary.

7. Undersigned counsel spoke to Complainant on August 18, 2017. Complainant does not consent to the continuance requested in this motion.

8. While Duquesne Light does not seek to unnecessarily delay the proceedings in this matter, Duquesne Light nevertheless believes that a continuance is appropriate under the circumstances outlined above. Additionally, given the currently scheduled hearing date is less than 20 days away, Duquesne Light Company respectfully requests that the response time to this Motion be shortened to 10 days.


