Dear Secretary Chiavetta:

On or about July 21, 2017, Duquesne Light Company was granted a 30 day extension, until August 23, 2017, to file a new Customer Assistance Program (CAP) design for review and approval by the Pennsylvania Public Utility Commission (Commission). By this letter, the Company is providing an update on recent stakeholder meetings and requesting a further extension until September 15, 2017 to file its new CAP design. The parties, namely the Office of Consumer Advocate (“OCA”) and the Coalition for Affordable Utility Service and Energy Efficiency (“CAUSE”), have authorized the Company to state that they are not opposed to this extension.

The stakeholder process is ongoing and the parties have tentatively reached a resolution on all issues, subject to the Company’s response to an outstanding data request from the parties. Duquesne Light believes that an additional extension is prudent as it will allow the parties to finalize an agreement and potentially eliminate the need for a hearing before an administrative law judge.


