**Data Request**

**TUS-1. Provide details of each of the services, and associated prices, provided by the affiliated companies to Reimer Natural Gas, LLC (Reimer) under the proposed agreements with Herman Oil and Gas, Inc. (Herman) and AES Specialized Services, LLC (AES). Applicants must include in the agreements that services between Reimer and Herman will be provided at cost, while services from AES to Reimer will be provided at the lower of cost or market.**

**Response**

Herman is regulated public utility and following the asset acquisition will have as employees a General Manager, Office Manager, Operations Supervisor and three Operations field employees. The employees will be responsible for rendering all tasks associated with usual utility service including administrative services such as recordkeeping, bookkeeping, customer service, resolving customer inquiries, billing, scheduling, safety, PUC compliance, DEP reporting, One-Call response, system monitoring, pressure checks, meter reading, leak repair, ROW clearance and maintenance, pipeline maintenance, meter changes and general operations support. The labor costs of salary, benefits, and overhead will be allocated between the two regulated utilities Herman and Reimer on a customer basis.

AES is an unregulated pipeline contractor that conducts business in Butler, Allegheny, and Armstrong, Potter, Tioga counties. Services rendered to Herman and Reimer will comprise less than 5% of AES revenues and will be charged at the same market prices as other customers. Pipeline construction and repair costs, and meter and service installations will be allocated on a direct cost basis to the specific utility receiving the work.

**TUS-2 In the agreement with SME Well Services, LLC, under what rate schedule(s) will Reimer receive services from Peoples Natural Gas Company, LLC and/or National Fuel Gas Distribution Corporation?**

**Response**

Reimer will receive services from Peoples Natural Gas under rate MSG-Commercial

Reimer does not anticipate taking service from National Fuel
