
Pursuant to the Commission's Interim Guidelines Regarding Notification by an Electric Generation Supplier of Operational Changes Affecting Customer Service and Contracts, Docket No. M-00960890F.0013 (August 13, 1998) ("Interim Guidelines"), this correspondence is to advise the Pennsylvania Public Utility Commission ("PUC") that Talen Energy Marketing, LLC ("Talen Energy") and Interstate Gas Supply, Inc. d/b/a IGS Energy ("IGS Energy") have entered into an Asset Purchase Agreement ("Agreement") for the acquisition by IGS Energy of certain retail electric supply customer accounts of Talen Energy in the Commonwealth of Pennsylvania. Specifically, Talen Energy has assigned to IGS Energy approximately 103,000 contracts for the provision of electric generation services to Pennsylvania retail customers. Talen Energy's license number is A-110098; IGS Energy's license number is A-2011-2228643.

As required by the Interim Guidelines, a thirty-day notice is being sent to the impacted customers to inform them of the contract assignments (forms of customer notices for fixed price and variable price accounts are attached). This notice includes the following information:

- The transfer of service from Talen Energy to IGS Energy will be initiated after the expiration of the thirty day notice period and that the effective date of the transfer is expected to occur on or about August 18, 2017.
- IGS Energy's mailing address is 6100 Emerald Parkway, Dublin, OH 43016.
- The telephone number for IGS Energy customer service representatives is 877-786-4447.

- An explanation that the reason for the contract assignment from Talen Energy to IGS
 Energy is to enable Talen Energy to focus its retail efforts on commercial and industrial
 customers.
- Additional information about the transition from Talen Energy to IGS Energy.

This transaction does not encompass all of Talen Energy's customers in Pennsylvania, and Talen Energy is not abandoning its license. The quarterly gross receipts of the customers being transferred, for the last eight quarters, is shown below:



Talen Energy is current with all quarterly reporting to the PUC Finance Section, and is current with all Pennsylvania AEPC Alternative Energy Credits.

Talen Energy and IGS Energy request that the Commission grant this notification confidential and proprietary treatment and place it in a non-public folder. The data provided herein is commercially sensitive information that Talen Energy and IGS Energy do not make public in any of our corporate reporting.
