Pursuant to § 62.105(b) this letter serves as EnerNOC, Inc.'s (the "Company") notification of change to the information included in the Company's registration as filed.

EnerNOC, Inc. has entered into an Agreement and Plan of Merger (the "<u>Merger Agreement</u>") with Enel Green Power North America, Inc. ("<u>Enel</u>") and Pine Merger Sub, Inc., a wholly-owned subsidiary of Enel, (the "<u>Merger Sub</u>"). The Form 8-K filed with the Securities and Exchange Commission and dated August 7, 2017 evidencing the consummation of the Merger (defined below) and changes in directors of the Company can be found at the following link: <u>http://investor.enernoc.com/secfiling.cfm?filing1D=1193125-17-249924&CIK=1244937</u>. The transactions contemplated by the Merger Agreement were consummated on August 7, 2017, and as a result, the Merger Sub merged with and into the Company (the "Merger"), and the Company survived and became a wholly-owned subsidiary of Enel. The Merger became effective at the time of the filing of a certificate of merger with the Secretary of State of the State of Delaware executed by the Company and Merger Sub (the "<u>Effective Time</u>").

We do not expect the Merger to result in any significant changes to the Company's operations.

The notice provided for in this letter shall be deemed to unconditionally satisfy the requirements for notice without the need of any further action by any party to the License.
