To whom it may concern:

On **January 25, 2017**, the Bureau of Investigation and Enforcement instituted a Complaint against **Dave's Airport Shuttle, LLC**, Respondent, for failure to file an application to abandon/discontinue its authority, a violation of 66 Pa. C.S. §1102(a)(2).

In accordance with 52 Pa. Code §5.61, the Bureau of Investigation and Enforcement notified the Respondent that, an Answer to the Complaint must be filed within twenty (20) days of the date of service. The Notice further specified that, if Respondent failed to answer the Complaint within twenty (20) days, the Bureau of Investigation and Enforcement would request that the Commission cancel Respondent's Certificate of Public Convenience.

The Complaint was served on Respondent, **Dave's Airport Shuttle, LLC** via U.S.P.S. Certified Mail on February 1, 2017. To date, more than twenty (20) days later, Respondent has failed to file an Answer to the Complaint.

Therefore, the allegations in the Complaint are deemed to be admitted. The Complaint is hereby sustained and the **Certificate of Public Convenience**, issued to Respondent, **Dave's Airport Shuttle, LLC**, at **Application Docket No. A-00119993** is **hereby CANCELLED**.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to **suspend** Respondent's commercial vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until all past due assessments are paid, all past due fines are paid, all insurance filings are up to date, and he holds an active Certificate of Public Convenience issued by this Commission.
