RE: RESPONDENTS DISCOVERY REQUEST Dated August 31, 2017  
(REQUEST FOR EXTENSIONS)

(We are returning First Set of Discovery Requests which are not complete at this time but want to docket that we returned them on time so that they will be certified as returned and answered to the best of our ability at this time and because we do not have the information in our possession, and are diligently working to get this information. To not afford us any time at all to answer Discovery wrecks of a breach of operating principles that each member of your profession is bound by...ESPECIALLY, when we made you aware by attaching one doctor's letter (Dr. Gisler) that Gerard has outstanding serious medical issues and you are aware of it.

Therefore, we are still requesting a humanitarian extension to be given more time to answer, and also a humanitarian extension to the trial date of December 12/13, 2017.)

On Wednesday, September 6, 2017, we received via the mail your 14 individual interrogatory Discovery request and have been given only 13 days to answer.

Date of letter/date of service is August 31, 2017. Due to holiday, we received request September 6, 2017. Letter states "you must respond to each discovery request within twenty days after the date of service". That gives us only 13 days to respond.

We are kindly Again requesting an extension of time for Discovery and a new date for our Hearing (December 12, 2017), since Gerard will be released from a nursing home before the question answers are due, and I can't take care of him and do all the legal work involved in a pro se case; therefore, we are kindly asking for a "humanitarian" extension of Discovery and Hearing date either until my husband gets well or passes over.

Attached is a letter from Dr. Chris Gisler MD showing some of the extent of his illness.

We are currently waiting on ALL of Gerard's past and current medical records referred to by Dr. Gisler in his letter from Gerard's primary care physician. These records are kept in Cont. Med. In Texas.

We request that ALL communication between parties be by written communication, and NOT verbal communication as you requested on Monday, September 11, 2017.

Again, in conclusion, we would very much appreciate being granted extensions.


