In response to the data request dated June 1, 2017, Great American Power, LLC ("GAP,,) has enclosed the responses, including attachments.


In accordance with 52 Pa Code § 1.36, the responses GAP has provided here are verified by the following statement:

Request 1. EGS Customers – After Great American Power, LLC (GAP) transfers customers to Oasis Power Holdings, LLC d/b/a Oasis Energy (Oasis) and Respond Power, LLC (Respond), will GAP have any customers remaining?

Response 1. After the transfers are complete, GAP does not intend to have any customers remaining on flow, though there may be a number that fail to transfer for technical reasons. GAP will continue to operate as an EGS in Pennsylvania after the transfers are complete.

Request 2. Gross Revenues – Please provide the past two years of GAP's gross revenues for the sale of electricity for the customers in Pennsylvania being assigned to Oasis and Respond. Please provide these Gross Revenues as quarterly amounts and separated based on the assignment to each EGS. GAP may elect to mark the information as 'Confidential'.

Request 3.
