Please accept this letter on behalf as Discount Power, Inc ("DPI") to reduce its required level of financial security to 5% of its most recent 12 months of gross receipts, consistent with the directives of the Secretarial Letter issued on April 8, 2016 in the above referenced docket.


Please find the following information and documentation in support of DPI's Letter Petition:

1. DPI's gross receipts in Pennsylvania for the four most recent quarters attached hereto as Appendix A (**CONFIDENTIAL**).
2. DPI's tax status letter from the Pennsylvania Department of Revenue indicating that DPI is current with its tax liabilities to the Commonwealth of Pennsylvania, attached hereto as Appendix B (**CONFIDENTIAL**).



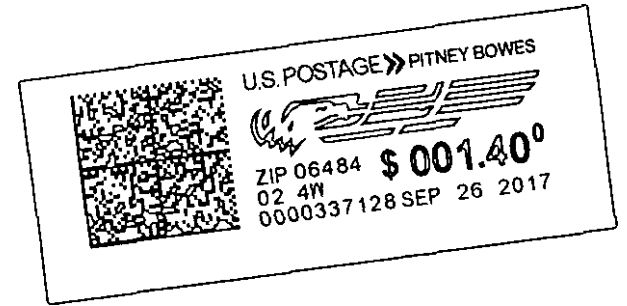
