Dear Mikayla Findley:

We are pleased that Navigate Power has applied for a license to provide Natural Gas Broker/Marketer Services on the distribution system of Columbia Gas of Pennsylvania, Inc. ("Columbia Gas").

Under Paragraph 2.4.5 of the Rules Applicable to Distribution Service section of the Tariff of Columbia Gas, Navigate Power could be required to provide to Columbia Gas a bond or other financial security instrument in an amount that Columbia Gas determines to be appropriate. Navigate Power has indicated only brokering and consulting services will be provided. Therefore, we have determined at this time that Navigate Power does not need a bond or other financial security requirement to provide broker natural gas services to Columbia Gas customers.

If the creditworthiness requirement or Columbia Gas' exposure to Navigate Power changes in the future, Columbia Gas might deem it appropriate to require Navigate Power to provide a bond or other financial security instrument.

Dear Mikayla Findley:

PECO is aware that Navigate Power, LLC has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.

In making such an application Navigate Power, LLC could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. Navigate Power, LLC has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers will not take title to any delivered natural gas; nor will accept any customer payments or deposits. Therefore, PECO has determined at this time that Navigate Power, LLC does not need a bond or other financial security requirement, since they are not directly engaging in business with PECO and only providing brokering or consulting services to PECO customers. However, if the services provided by Navigate Power, LLC or the creditworthiness requirement for PECO's exposure to Navigate Power, LLC changes in the future, PECO reserves the right to require Navigate Power, LLC to provide a bond or other financial security instrument.

We are pleased that Navigate Power LLC has applied for a license to provide natural gas services on the Peoples Group of Companies. Based on your assertion that Navigate Power, Inc. ("NAVIGATE") is applying with the State of Pennsylvania to operate as a natural gas broker/marketer, UGI Utilities Inc. ("UGIU") has concluded that NAVIGATE will not need to post security with UGI-Central Penn Gas ("CPG"), UGI-Penn Natural Gas ("PNG") or UGI Utilities Gas Division ("UGI"). This is based on the declaration that NAVIGATE will not be taking title to gas or directly serving end use customers. This also assumes that NAVIGATE will be acting in conjunction with a licensed Natural Gas Supplier who has been approved by the Pennsylvania Public Utility Commission to serve in the applicable UGIU service territories and who has posted the required financial security as specified in the respective UGIU tariffs. If NAVIGATE wishes to directly serve Choice customers in the service territories of UGI, PNG and/or CPG in the future as a natural gas supplier, it will have to post security as specified in the respective UGI tariffs prior to the commencement of the service.
