This letter is in response to Complaint Docket No. C-2017-2624223 dated September 20, 2017 filed against South Side Salvage, Inc by the Bureau of Investigation and Enforcement, stating that operating authority issued to South Side Salvage Inc. on 12/23/03 with a Number of A-00120320 is under suspension effective September 1, 2017 for failure to maintain evidence of insurance on file with the commission.

We changed insurances this year from Plaza Insurance Company which was produced for us through Centerpointe Insurance Service with a California License #0735759, located at 807-B Camarillo Springs Road, Camarillo, CA to Zurich American Insurance Company and Great American Alliance Insurance Company , both of which are produced by YouZoom, Insurance Services Inc., 6900 College Blvd., Ste. 1000, Overland Park KS 66211.


The filing with the PA Public Utility Commission was overlooked by the new producer in the correct time frame about which we received a complaint dated September 20, 2017; however, it was filed by the producer correctly which generated a Notice to Lift Suspension of PUC Operating Authority on September 22, 2017.

We have maintained all insurances for the operation of our company, South Side Salvage, Inc. since it's inception in 2003 and the granting of our PUC Operating Authority that same year. We regret this oversight through changing insurance companies and producers of same, and we understand that your commission is aware that the filings by the insurance producer were completed, as stated by the Notice To Lift Suspension of PUC Operating Authority two days after Complaint was issued.

South Side Salvage, Inc. respectfully requests that the Civil Penalty in the amount of \$500.00 be waived, as this issue was not an attempt to be non-compliant, but was rather an oversight during the change from one insurance company to another in our proof of renewal not being executed in the correct time frame. The insurance was effective September 1, 2017, as evidenced on the Certificates of Insurance issued.

We trust that you will make any considerations that can be afforded us in this request for resolution of this matter.

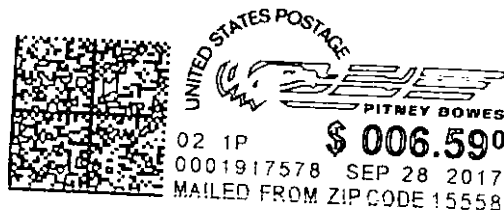
