Carl Harford LLC (Respondent) has paid the agreed-upon civil penalty sought by the Bureau of Investigation and Enforcement (I&E) of the Pennsylvania Public Utility Commission (Commission) in order to resolve the above-docketed complaint without litigation.

On September 28, 2017, the Commission received a money order from Respondent in the amount of \$250, which constitutes payment of the civil penalty sought by I&E regarding the allegation that Respondent failed to file evidence of cargo insurance with the Commission in violation of 66 Pa.C.S. § 512 and 52 Pa. Code §§ 32.2(c), 32.12(a), and 32.13(a).
