MOTION FOR CONTINUANCE OF HEARING


Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works, the Respondent ("PGW") hereby submits this timely request for a continuance of the hearing in this matter, which is scheduled for Monday, October 23, 2017. In support of its motion, PGW states as follows:

1. By Notice dated August 28, 2017, the Commission scheduled an In-Person Hearing in this matter for Monday, October 23, 2017 at 10:00 a.m., before Administrative Law Judge Christopher P. Pell.
2. Pursuant to 52 Pa. Code §5.231(a), PGW is in communication with the Complainant and is attempting to reach a settlement in this matter. As PGW and the Complainant are still waiting on documents necessary to the resolution of this case, it is unlikely that a resolution will be reached prior to the scheduled hearing date.
3. PGW has contacted the Complainant by telephone to discuss a continuance in this matter. The Complainant agrees that a Continuance is in the best interest of both parties.

WHEREFORE, Complainant requests that the hearing scheduled for Monday, October 23, 2017, in the above captioned matter be continued and rescheduled so that PGW and the Complainant may attempt to reach a settlement.


