LICENSE AGREEMENT

The undersigned Grantor, COUNTY OF ALLEGHENY, a municipal corporation, for good and valuable consideration, the receipt of which is hereby acknowledged, does hereby grant unto Duquesne Light Company, its successors and assigns, for providing, transmitting and/or distributing electric and/or communications services for any and all purposes, the license to erect, install, use, own, operate, maintain, repair, renew and finally remove an electric line, consisting of two (2) poles (#224301 and 224302), together with crossarms, cables, wires, two (2) anchors, guys and other fixtures and apparatus thereto belonging, upon, over, under, along, across and through Grantors land, fronting on Muse Lane @ McClintock Road and Sylvan Drive, situate in White Oak Borough, Allegheny County, Pennsylvania (having Tax I.D. 648-R-374) and shown on Duquesne Light Company Drawing No. 442320-T1, a copy of which has been given to Grantor and is attached hereto; Duquesne Light Company shall also have the following rights: to trim or remove any trees or shrubbery which, at any time or times, may interfere or threaten to interfere with the erection, installation, use, operation, maintenance, repair, renewal or removal of the electric line; to enter upon the land at any time for such purposes; to permit others to attach crossarms, cables, wires and related apparatus, and to use the poles and apparatus erected hereunder; and to sell, assign, lease or otherwise transfer any or all of the rights hereunder.

Duquesne shall file a copy of this Agreement with the Pennsylvania Public Utility Commission as required by Title 66, Section 507 of the Public Utility Code and this Agreement shall become effective in accordance therewith.

Intending to be legally bound the parties have executed this agreement this 20th day of September, 2017.
