Please consider this letter formal notification that ARM Energy Management, LLC (ARM) is in the process of transferring customers on the three Peoples NGDCs on which we are licensed to operate to Peninsula Energy Services Company, a Delaware corporation and direct subsidiary of Chesapeake Utilities Corporation (PESCO), PA PUC A-2015-2528013 (approved Feb 29, 2016).

With the transaction, several ARM employees have accepted employment at PESCO, however we did not sell the company and do not intend to abandon ARM's licensing in PA. The transaction has an effective date of August 1, 2017, but as you are aware the administrative activity has a significantly longer lead time and is expected to be fully completed by December 31, 2017.
