Ms. Chiavetta:

This letter is to address an apparent inconsistency in PUC policies for filing documents and making them available for public inspection. It also follows an earlier letter (October 11, 2017) regarding a particular document, "Answer to Motion for Summary Judgment" which was filed on June 8, 2017, but is not shown on the website list for the relevant case (Docket # C-2015-2511904).

In a phone conversation with your office yesterday, I inquired again about this document's absence. I spoke with a supervisor, Melissa, and referred to my previous letter (October 11, 2017) regarding this matter. I asked whether and when the "Answer to Motion for Summary Judgment" would be added to the public file. Melissa verified that the documents related to this matter were received and were in the hands of ALJ Dennis J. Buckley.

Melissa also provided an explanation for the omission in the published record. She stated that a document which is identified as an "Answer" is not made available on the list for public inspection.

Curiously, a similar "Answer to Motion" [for a stay of proceedings] filed on February 15, 2017 does appear and is available for public inspection. The inclusion of that "Answer" clearly contradicts the policy that Melissa described.


In light of this discrepancy, it seems appropriate that the "Answer" filed on June 8, 2017 should also appear. I'm requesting that it be added to the public record along with the relevant Certificate of Service (dated June 8, 2017) which is already listed.

As I indicated in the letter of October 11, an E-file Confirmation for 1680653 (enclosed) verifies that the "Answer" was received and filed, along with the Certificate of Service.

A copy of this letter is also being provided to PPL Electric via Mr. Christopher T. Wright, and I retain a copy in my own files.

I look forward to your response to this letter and ask that the response be made in writing.



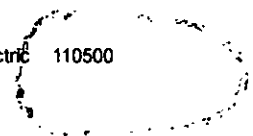

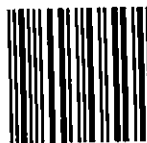
