STATUS REPORT OF THE DEPARTMENT OF TRANSPORTATION


The Pennsylvania Department of Transportation (“Department”) hereby files the following Status Report, pursuant to the requirements of Ordering Paragraph 21 in the Commission’s Opinion and Order entered October 31, 2007, in the above-referenced matter. This status report pertains to the work ordered to be performed by the Department pursuant to the Commission’s Opinion and Order entered on October 9, 1997, as subsequently modified.

1. The Commission entered an Order dated October 27, 2016, approving the Joint Petition resolving the outstanding issues at Pumping Station Road. The work to be performed at this location

has been delayed. A preconstruction meeting was held on October 31, 2017. It is now anticipated that the work will be concluded by September 30, 2018. The parties will advise the Commission when the work is completed.


