MUTUAL RELEASE AND SETTLEMENT AGREEMENT

This Mutual Release and Settlement Agreement ("Agreement") is entered into between the following parties: Godfrey Zimba, and Clearview Electric, Inc. ("Clearview")

Mr. Zimba filed a formal complaint against Clearview with the Pennsylvania Public Utility Commission in Docket No: C-2017-2616037.


Clearview does not admit any fault or wrong doing. However, in exchange for complete resolution of this matter, Clearview Electric, Inc. has refunded Godfrey Zimba One Dollar and Eighty Two Cents for the difference in rate charged to him from July 19, 2017 through July 24, 2017. This payment was made payable to Godfrey Zimba and mailed to 220 E. Mermaid Lane, Apartment 133, Philadelphia PA 19118 on 7/27/17.

Clearview has added Mr. Zimba to its internal No Not Call/Do Not Solicit list. This should prevent any entity working on behalf of Clearview from contacting Mr. Zimba in the future, and will prevent Clearview's system from enrolling his account for service with Clearview again in the future.

Upon execution of this Agreement, Godfrey Zimba agrees he will not pursue any further action against Clearview Electric, Inc. and will consider this complaint closed.
