<u>Item 8.a: Experience, Plan Structure</u>: The information in Rider No. 1 under the following headings is updated as follows:

 Applicant's Previous Experience in the Electricity Industry: The third paragraph is removed and replaced with the following:

The Electricity Broker Services are conducted by the company's Energy Division, which has an office located in the metropolitan New York City region. The Energy Division is under the direction of Matt Eggers, Vice President of Energy for Yardi. The Electricity Broker Services personnel were previously employed by MCENERGY, INC. (MCE), a New York corporation founded by Margaret Carey in 1996. MCE started to provide energy consulting services, including Electricity Broker Services, to the commercial real estate community in New York City in 1999. Since then, MCE expanded its operations to include the northeastern U.S., including the Chicago metropolitan region.

- New Jersey: Yardi was issued an "Energy Agent Registration" on 10/20/17 by the New Jersey Board
 of Public Utilities (Registration No. EA-0458).
- <u>Staffing Structure and Numbers and Employee Training Committments</u>: The third paragraph is removed and replaced with the following:

The client services for the Electric Broker activities are conducted by the company's Energy Analyst Team, which reports to Daniel Rice, Manager – Client Services, who is responsible for the day-to-day operations of the Team. Mr. Rice reports to Mr. Eggers, VP – Energy. Mr. Rice is based in New York, and Mr. Eggers is based in Yardi' office in San Francisco, CA. Mr. Eggers is responsible for the financial and corporate integration of the Energy Division with Yardi's upper management. Mr. Eggers reports to Anant Yardi, President and founder of Yardi.

The Energy Analyst personnel each have experience and expertise in the company's Electric Broker service offerings. The company's training commitments for new and existing employees is as follows:

- New employees are trained by senior staff on process and procedures as documented in the company's business manual;
- Weekly staff meetings are conducted to manage the client process, address client concerns and share information and resolution techniques among staff;
- Monthly seminars are held on different topic on energy market trends and regulatory changes;
- The company maintains subscriptions to trade journals and on-line energy reports to keep abreast of current market developments; and
- The company pays for employees to attend industry-sponsored energy forums and seminars.

<u>Item 8.d: Oversight of Marketing</u>: The paragraph in Item 8.d in Rider No 1 is removed and replaced with the following:

Marketing activities for the Electric Broker Services are the responsibility of Matt Eggers, Vice President of Energy, with the assistance of a Sales Director and Sales Associates. Marketing efforts are based on development of existing client relationships, referrals, responses to client RFPs, and maintenance of the company website. Yardi will use its own internal resources and employees for marketing, and Yardi will not use subcontractors for its marketing activities. Yardi will not be engaging in any telemarketing or door-to-door sales solicitation activities.

Item 8.e: Officers: The first paragraph in Item 8.e in Rider No. 1 is removed and replaced with the following:

Daniel Rice, Client Services Manager, is directly responsible for the operations of the Electricity Broker Team. Mr. Rice reports to Mr. Eggers, Vice President of Energy. Mr. Rice is based in New York, and Mr. Eggers is based in Yardi's office in San Francisco, CA. Mr. Eggers is responsible for the financial and corporate integration of the Energy Division with Yardi's upper management. Mr. Eggers reports to Anant Yardi, President and founder of Yardi. The professional resumes for management personnel directly responsible for the operations of the Energy Broker Services are as follows:

ORDER

FORMAL CASE NO. EA 2017-04, IN THE MATTER OF THE APPLICATION OF YARDI SYSTEMS, INC. FOR AN ELECTRICITY SUPPLIER LICENSE, Order No. 18802

I. INTRODUCTION

1. By this Order, the Public Service Commission of the District of Columbia ("Commission") grants a license to Yardi Systems, Inc. ("Yardi Systems" or "Applicant") to function as an electricity supplier in the District of Columbia. Yardi Systems Inc.'s license is effective upon issuance of this Order.

II. <u>BACKGROUND</u>

- 2. On January 30, 2017, Yardi Systems filed its license application.² Specifically, Yardi Systems intends to operate as a broker of electricity for commercial and industrial customers in the District of Columbia, pursuant to Section 34-1505 of the "Retail Electric Competition and Consumer Protection Act of 1999 ("Act")." Pursuant to the Commission's licensing requirements as set forth in Order No. 11796,⁴ Yardi Systems has provided the following information:
 - a) Proof of technical and managerial competence;
 - b) An affidavit of compliance with applicable Federal and District of Columbia environmental laws and regulations dated January 19, 2017;
 - c) Proof of financial integrity to include financial statements;

D.C. Official Code § 34-1501(17) (2001) defines, in part, an electricity supplier as "a person, including an aggregator, broker, or marketer, who generates electricity; sells electricity; or purchases, brokers, arranges or markets electricity for sale to customers."

- d) Proof that Yardi Systems has registered with the Department of Consumer and Regulatory Affairs to do business in the District of Columbia;
- e) An affidavit dated January 19, 2017, stating that Yardi Systems is subject to all applicable taxes;
- f) An affidavit dated January 19, 2017, stating that Yardi Systems will comply with all the requirements of all orders and regulations of the Commission; and
- g) Applicant's website address: http://www.yardi.com.

Yardi Systems filed supplemental financial information on April 4, 2017.5

III. DISCUSSION

3. Our review of the information contained in Yardi Systems' application, demonstrates that it has met all the prescribed licensing requirements and that the Applicant has the ability and the financial integrity to serve electricity customers in the District of Columbia. The Commission also finds that granting Yardi Systems' application will serve the public interest. Accordingly Yardi Systems' application is approved.

THEREFORE, IT IS ORDERED THAT:

4. The application of Yardi Systems, Inc. for a license to conduct business in the District of Columbia as an electricity supplier is hereby **GRANTED**. Yardi Systems Inc.'s license is effective upon issuance of this Order.
