HISTORY OF THE PROCEEDING

On July 27, 2017, Terra Evans (Complainant) filed a formal Complaint against Philadelphia Gas Works (PGW or Respondent) with the Pennsylvania Public Utility Commission (Commission) at Docket No. C-2017-2620433. In that Complaint, the Complainant contends that there were incorrect charges on her bill at her service address¹ and requests a payment arrangement.

On August 3, 2017, PGW shut off the Complainant's service at her service address for non-payment. On August 9, 2017, the Bureau of Consumer Services (BCS) issued a


