COMPLAINT RESPONSE

SECRETARY CHIAVETTA:

RAMON VASQUEZ T/A VASQUEZ TRANSPORTATION (NKA VASQUEZ TRANSPORTATION LLC) HERBY REDQUESTS AN APPEAL OF THE COMPLAINT FOR C-2017-2625831

1) THE RESPONDENT, RAMON VASQUEZ, HEREBY STATES THAT HE RECEIVED A NOTIFICATION OF AUTHORITY SUSPENSION FROM THE PENNSYLVANIA PUBLIC UTILITY COMMISSION, ON OR ABOUT SEPTEMBER 15, 2017. THE LETTER WAS DATED SEPTEMBER 12, 2017. ONCE MR. VASQUEZ RECEIVED THE LETTER, HE CONTACTED HIS INSURANCE CARRIER AND WAS TOLD THAT INSURANCE COVERAGE HAD BEEN CANCELLED, (MR. VASQUEZ DID NOT RECEIVE A NOTICE OF CANCELLATION) AND HE ATTEMPTED TO OBTAIN COVERAGE WHICH WAS TO BE FILED WITH THE PENNSYLVANIA PUBLIC UTILITY COMMISSION.

2) MR. VASQUEZ PREVIOUSLY RESPONDED ON SEPTEMBER 22, 2017, STATING THAT OPERATIONS WERE CEASED ON SEPTEMBER 15, 2017 (APPROXIMATE DATE THAT HE WAS NOTIFIED BY THE PENNSYLVANIA PUBLIC UTILITY COMMISSION). MR. VASQUEZ OBTAINED INSURANCE COVERAGE AND WAS MISINFORMED TO CONTINUE OPERATIONS BY THE INSURANCE CARRIER.

3) THE INSURANCE COVERAGE (EFFECTIVE SEPTEMBER 18, 2017) WAS FILED WITH THE PENNSYLVANIA PUBLIC UTILITY COMMISSION AND MR. VASQUEZ RESUMED OPERATIONS. AS PER THE RECORD OF HOURS, IT IS NOTED THAT OPERATIONS CEASED ON SEPTEMBER 15, 2017 AND RESUMED ON SEPTEMBER 18, 2017.

4) THEREFORE, RESPONDENT IS HEREBY REQUESTING REVIEW OF THE COMPLAINT, REMOVAL OF ANY AND ALL FINES ASSOCIATED WITH SUCH COMPLAINT, AND DISMISSAL OF ANY CANCELLATION OF THE CERTIFICATE OF PUBLIC CONVENIENCE AT A-2016-2561641.
