RELEASE AND WAIVER AGREEMENT

WHEREAS, Duquesne Light Company ("Duquesne") agrees to pay to the City of Pittsburgh Department of Public Works the amount of **ninety-six thousand, six hundred fifty four dollars (\$96,654.00)** for restoration work (the "Work") as further detailed herein; and

WHEREAS: the City of Pittsburgh Department of Public Works agrees to use the full amount of the payment solely for the Work as set forth herein: and

WHEREAS, the City of Pittsburgh Department of Public Works is willing to release and indemnify Duquesne for any and all claims associated with such Work.

NOW THEREFORE, in exchange of sufficient and mutual consideration, the receipt of which is acknowledged by both Parties, the Parties hereby agree as follows:

The City of Pittsburgh Department of Public Works agrees to perform the following work, and/or have the following work completed by subcontractors:

The following Streets will be milled and paved by the City of Pittsburgh Department of Public Works. Duquesne will pay \$18.10 per square yard for 5,342 total square yards of impacted yardage.

- Liverpool St: from Allegheny Ave to Manhattan St. (3950 yd²)
- Manhattan St: from Liverpool to Columbus Ave. (1390yd²)

The City of Pittsburgh agrees to release and forever discharge Duquesne, its parent, affiliates and/or subsidiaries, and all of their respective employees, officers, directors, agents and shareholders, from all claims which the City of Pittsburgh has or may hereafter have for loss, damage or injuries of any kind to the City of Pittsburgh's property, employees, agents, representatives or contractors, or any other claims related to or arising from the performance of the Work.

Utility shall file a copy of this Agreement with the Pennsylvania Utility Commission as required by Title 66, Section 507 of the Public Utility Code, and this Agreement shall become effective in the accordance therewith.

IN WITNESS WHEREOF, the parties hereto have caused this Release and Waiver Agreement to be executed by their duly authorized representatives.
