PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests that the evidentiary hearing in the above-captioned matter, which is currently set to be held on January 31, 2018, be rescheduled for March 29, 2018. The Company recently retained two expert witnesses for this case, and they are unavailable for the hearing on January 31, 2018.

Pursuant to your Prehearing Order dated October 4, 2017, I sent a letter to Mr. Kline on December 14, 2017, requesting that the hearing be rescheduled and providing a list of dates when PPL Electric would be available for the rescheduled hearing. Mr. Kline replied via written correspondence dated December 18, 2017, and stated that he has a vacation scheduled for the current hearing date of January 31, 2018.
