PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests that the evidentiary hearing in the above-captioned matter, which is currently set to be held on January 30, 2018, be rescheduled for March 8, 2018. The Company recently retained two expert witnesses for this case, and they are unavailable for the hearing on January 30, 2018.
