
Recently a letter was received regarding the failure to maintain evidence of insurance on file with your Commission.

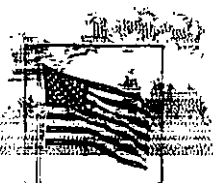
