PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests that the evidentiary hearing in the above-captioned matter, which is currently set to be held on January 30, 2018, be rescheduled for March 23, 2018. The Company recently retained two expert witnesses for this case, and they are unavailable for the hearing on January 30, 2018.

Pursuant to your Third Prehearing Order dated October 3, 2017, I sent a letter to Mr. Bervinchak on December 14, 2017, requesting that the hearing be rescheduled and providing a list of dates when PPL Electric would be available for the rescheduled hearing.
