I have recently filed for Electricity and Natural Gas Broker Licenses on behalf of my company Apollo Edison LLC. I am sending along this letter and documents in follow up to that application in hopes of completing and rectifying that applications for timely approval.

I have received 2 letters, 1 for Electricity and 1 for Natural Gas concerning the Fictitious Name, stating:

"Your fictitious name must be registered with the Pennsylvania Department of State before we can process your application if you intend to use "Apollo" as your fictitious name."

I would like to clarify that as noted in Section 2, that Apollo Edison LLC will not be using a fictitious name.



The Applicant will not be using a fictitious name.

I apologize for the confusion around this matter, but referring to "Apollo" was intended more for internal verbal abbreviation and not as a Fictitious or DBA Name. I have included the first 2 pages of each application below correctly modifying the documents excluding "Apollo" as a fictitious name and reiterated that this will not be used in Section 2. I have also included copies of the original letters received for reference.


