Here is our answer to this Complaint **Docket No. C-2017-2638642**, dated December 19, 2017.

As seen with the enclosed documents we do have insurance and have been fully covered the whole time by commercial insurance.

What had happened was our independent insurance agent with whom we had the insurance policy Mosholder Jack E. LTD was informed by the original insurance company that they no longer insure commercial trucks and that he would have to go through another insurance company for our policy, the agent then provided us with a new company. When the switch to Progressive commercial policy, underwritten by United Financial Casualty Company, back on October 26, 2017 with the Policy period Nov. 1, 2017- Nov 1, 2018, we had thought that Progressive Commercial then had provided the PUC with all the documentation that was needed back in late October early November.

We only discovered through your first letter informing us that you had not received the proof of insurance that the information was not sent out. We then called Mosholder and informed them to promptly send over the information needed which Progressive failed to send out.

With receiving your second letter which was sent by certified mail arriving here on December 20th we found out that Progressive failed to send out you required information. Again we informed our insurance agent and we also called Progressive. With that phone call we found out that there was not a request to send info to the PUC but someone within the insurance company did not understand and only submitted information to the Federal DOT.

We are sorry for the delay and if we had known we would have had that information to you on time. We did not know this was happening. Progressive since has sent you the information and we are providing it to you in this letter too.

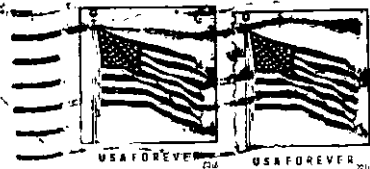
