PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests that the evidentiary hearing in the above-captioned matter, which is currently set to be held on January 29, 2018, be rescheduled for April 3, 2018. The Company recently retained two expert witnesses for this case, and they are unavailable for the hearing on January 29, 2018.

Pursuant to your Third Prehearing Order dated October 3, 2017, I sent a letter to Mr. Forney on December 14, 2017, requesting that the hearing be rescheduled and providing a list of dates when PPL Electric would be available for the rescheduled hearing. Subsequently, I sent an email to Mr. Forney following up on the December 14, 2017 letter.
