Sidney Smith T/A SES Trucking ("Respondent") has paid the agreed-upon civil penalty sought by the Bureau of Investigation and Enforcement ("I&E") of the Pennsylvania Public Utility Commission ("Commission") in order to resolve the above-docketed complaint without litigation.

On November 7, 2017, Respondent's insurer filed evidence of liability insurance with the Commission, and on November 13, 2017, Respondent's insurer filed evidence of cargo insurance with the Commission. On January 16, 2018, the Commission received a money order from Respondent in the amount of \$250, which constitutes payment of the agreed-upon civil penalty sought by I&E regarding the allegation that Respondent failed to file evidence of liability and cargo insurance with the Commission in violation of 66 Pa.C.S. § 512 and 52 Pa. Code §§ 32.2(c), 32.12(a), and 32.13(a).

Accordingly, pursuant to 52 Pa. Code § 5.24(a), I&E files this letter to certify that the above-docketed proceeding has been satisfied and should be marked closed. Should you have any questions, please do not hesitate to contact me.


