

I am writing to you to respectfully request that the \$500 fine that has been levied against me be lifted.


I discontinued by for hire operations within Pennsylvania on 10/22/17, the same day that my insurance policy cancelled. At no time was I operating without insurance.





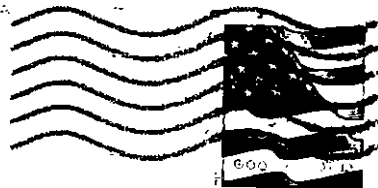
