In accordance with the directives of Ordering Paragraph 2 of the November 6, 2017 Corrected Interim Order Granting Third Request for a Continuance in the above captioned matter, UGI Utilities, Inc. – Gas Division (“UGI”) hereby submits the following status report with the consent of Marotta Main Architects (“Complainant”).

Complainant continues to seek certain property rights from a third party that would facilitate the placement of its gas meter behind its building, which would satisfy its complaint. It has authorized UGI to request a further sixty-day continuance of this proceeding to be followed by the filing of a further status report. UGI representatives are also currently scheduled to meet with Complainant at the service address on Friday January 26, 2018 to explore other options for resolving the complaint.
