RE: Exception of Nancy and Edmond Zeibari to Initial Decision granting request for leave to withdraw complaint of the office of Administrative Law Judge.

Please be advised that I (we) must file this Exception in consideration of an error that has been made.

I (we) still do not consent to the installation of a PECO AMI or Smart Meter at our domicile because of privacy and health concerns nor could I appear at a hearing due to the stress involved.

However, on page 4 of your communication dated January 4, 2018, line 2 states that "There are no other parties involved in this matter..." and therein lies the basis of my (our) objection.

While 'Edmond Zeibari' is written correctly on the envelope and referred to as my husband in the letter (p.2), a new party has indeed been introduced on the cover page and page 1. This is a 'Harold Zeibari' whom we do not know and who is nowhere named in our account with PECO Energy Company.

I (we) do not wish my (our) name(s) to be recorded with that of 'Harold Zeibari' in the official record at Docket No. C-2017-2617281 and marked closed.

I (we) would be remiss in not taking Exception to this.

Since the Initial Decision refers to an unknown person (i.e. Harold Zeibari) whose inclusion compromises the integrity of the case, and in order to permit a "just, speedy and inexpensive determination" (p.4) of the matter, I propose the following:

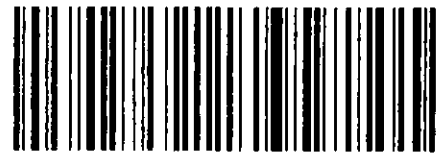
1. that the name of the Complainants be corrected, including the misspelled 'Zeibarari' p.11.4.
2. that the title 'Mrs' replace 'Ms.' throughout.
3. that the complaint still stand.
4. that the judgment of the Pa Public Utility Commission be in our favor, thereby precluding any plan by PECO Energy Company to install an AMI or Smart Meter on our property.
