PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests that the evidentiary hearing in the above-captioned matter, which is currently set to be held on January 29, 2018, be rescheduled for one of the following dates: June 4, 5, 6, 7, 8, 15, 18, or 19, 2018. The Company has retained two expert witnesses for this case, and they are unavailable for the hearing on January 29, 2018.

Pursuant to your Second Prehearing Order dated October 4, 2017, I sent a letter to Mr. and Ms. Zimmerman on December 14, 2017, requesting that the hearing be rescheduled and providing a list of dates when PPL Electric would be available for the rescheduled hearing. Ms. Zimmerman and I spoke on December 27, 2017, and she indicated that she and her husband would be amenable to rescheduling the hearing for some time at the end of May 2018. Subsequently, through the exchange of emails, it was determined that there were no dates in May when both parties would be available. Consequently, the parties agreed to look into dates in June 2018 for the hearing. On January 19, 2018, I sent an email to Ms. Zimmerman providing her with the dates in June that the Company would be available. As of filing this letter, I have not heard back from Ms. Zimmerman.

Considering the current hearing date is approaching, PPL Electric respectfully requests that the hearing be rescheduled for one of the dates in June provided above.
