Dear Judge Jones:

Pursuant to your letter dated January 2, 2018 and Order #3 in the above referenced matter, this is to report on the status of this matter with respect to the terms of the confidential settlement contained in Order #3.

Under the terms of the settlement contained in Order #3, the Complainant, Mr. Ross was to have made payments to PGW between the date of the order (February 15, 2017) through December 31, 2017, to his account in any payment increment of his choosing so long as the payments added up to \$4,000 by December 31, 2017. (Order #3, paragraphs 1 and 4)

This is to report that as of this date PGW records for Mr. Ross' account do not reflect that any payments have been made pursuant to the terms of the settlement. Thus, PGW has not restored gas service to the Mr. Ross' residence, 622 W. Chew Avenue, 2f, as envisioned by the terms of the settlement (Order #3, paragraph 4).

Therefore, pursuant Order #3, PGW requests that the Commission schedule a further hearing for this matter.
