
4. This directly affects me by :

- a. It will make me loose my boarding business as boarders will not board at a location that has these high voltage power lines to ride around. They throw off shocks that would scare horses. I need that income to pay my bills. I can not survive without that income.
- b. My liability insurance will go so high I will not be able to afford it. It will put me out of business.
- c. We have over 50 students that ride here and it would not be safe for them to ride the trails.
- d. My Grandchildren will be limited to the farm expansions as no building can be build around the lines.
- e. I will have to pay the taxes on ground I cannot use and essentially be paying taxes for all rate payers.
- f. I need the land to make a living, We harvest the timber every 10 years, it would prohibit future cuttings as timber buyers do not want to harvest around high voltage lines, it would take away my land that I need to make a living.
- g. It would take away part of my hay field that I need to feed my horses, making me purchase hay from another source, making it a yearly cost to my business that I should not have to make.

WHEREFORE, Steve + Dolores Krick respectfully requests Pennsylvania Public Utility Commission to investigate and the filing, and strongly impose a condition that all other existing rights of way and infrastructure should be utilized before any new power line projects are approved, and **the Commission should deny the Transource filing.**


