- 2. Our interest in this project is as landowners, farm owners, and residents of Hopewell Township, York County. We've been notified that the project would require an easement on our property.
- 3. The grounds for our protest of this proposal:

We are concerned about the future property value and impact on the local businesses and farms in the area. We reside on this property and enjoy the beautiful views which will be ruined by this project. We have concerns about the effects of this project on water quality, health effects, and the ability of our farm to expand to direct-to-customer sales.

4. This directly affects us because the proposed route of the line would impact views from every location on the property. This property has been in our family for four generations. We are concerned about the potential diminished value and enjoyment of the property. It could potentially affect the income derived from leasing the farm land for crop production. We elected to put a large portion of the property in federal agricultural preservation in order to ensure that farmland remains protected for the future generations and the environment. Our property contains streams, wooded areas, open crop land and underground springs, all of which benefit the diverse wildlife that inhabit this area. We have further concern on the potential effects on livestock and our own health from these lines.

WHEREFORE, Stephen, Michael and Eva Hecner and Theresa Norris respectfully request the Pennsylvania Public Utility Commission to fully investigate the costs and benefits of the filing, strongly impose a condition that all other existing rights of way and infrastructure should be utilized before any new power line projects are approved, and the Commission should deny the Transource filing.
