i, say i, write this correspondence to put on the record that i, am not making a "complaint" and i, am not a "complainant"; i, will be present as a man to press a claim when necessary;



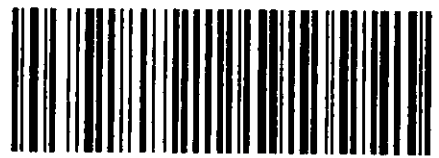
