PROTEST

- 1. The name and contact information of the Protestant is as follows: Leonard M. Traynor of 523 Alum Rock Road, New Park, PA 17352
- 2. My interest in this project is as landowner and resident of Fawn Township, York County.
- 3. The grounds for our protest of this proposal:
 - a. There is absolutely no documented evidence that this project is needed and by transources own estimate, would save targeted electric users with a savings of less than two dollars per year. It is estimated that it may cost York county residences more for their electric services.
 - b. Potential health hazard to us and our neighbors. Hundreds of studies worldwide have shown that **living** next to high voltage **power lines** and other parts of the **power** transmission network increases your risk of cancer and other health problems. The closer you are the more you are bombarded with dangerous EMFs. The safe distance for common EMF high voltage power lines on metal towers is 700 feet+.
 - c. The loss of our beautiful surroundings. The 130 foot clear-cut right of ways will scar the wood lands and damage animal habitat for ever. The towers and transmission lines will permanently deface our lands.
 - d. There are at least two existing right of ways that can be used to facilitate this project and at significate estimated cost reduction. We have not seen any studies or cost estimates from Transource as to why these options can't be utilized. Could it be that a new right of way would benefit them and only them. What is best for the community?
 - e. Common mode electrical noise can cause system shutdowns relating to signal transmission problems not to mention high voltage spikes. This is a huge problem that should be diligently

- research. There are many examples of studies and lawsuits regarding electronics, electrical equipment, dairy animals, and health issues associated with these issues.
- f. Over-the-air television, radio, and cell signals can be negatively impacted by the towers and transmission lines.
- g. The negative effect on our farmers and community property values cannot be over emphasized.

4. This directly affects me by:

- a. The landscape destruction and limiting usage of our farm property and the surrounding country side. The effect on the environment and animal habitat should not be minimized.
- b. The property market value losses to us and the communities will be substantial. The building lots we purchased as a nest egg for our retirement will prove to be a very bad investment indeed.
- c. The loss of precious memories, quality of life and general wellbeing due to the 130 feet clear cut right of way, electric towers, and power lines that will forever dot our property and the neighborhoods of southern York County
- d. The financial loss and labor we applied over the last 46 years to obtaining and improving this property for our family and future generations. We and the land can't recover if this project is approved. Please do not approve this project unless proven necessary and cost justified.

WHEREFORE, Leonard M. Traynor respectfully requests Pennsylvania Public Utility commission to investigate the filing and strongly impose a condition that all other existing rights of way and infrastructure should be utilized before any new power line projects are approved. The **commission should deny the Transource filing.**
